



STATE INCENTIVES FOR THE DEVELOPMENT OF INDUSTRIAL PARKS

With the adoption in 2021-2022 of amendments to the Law of Ukraine "On Industrial Parks" provides for measures to stimulate the state of arrangement and operation of industrial parks (IP), namely:


creation of business entities and participants of industrial parks at the expense of the state, local budgets and from other sources not prohibited by law:

- 1) full or partial compensation of the interest rate on credits (loans) for the arrangement and / or implementation of economic activity within the FE in the manner prescribed by the Cabinet of Ministers of Ukraine;
- 2) funds are provided on a non-refundable basis for the arrangement of industrial parks and / or ensuring the construction of related infrastructure (highways, communication lines, heat, gas, water and electricity, utilities, etc.), necessary for the creation and the functioning of individual entrepreneurs in the manner prescribed by the Cabinet of Ministers of Ukraine;
- 3) compensation of expenses for connection and attachment to engineering and transport networks is carried out in the order established by the Cabinet of Ministers of Ukraine;
- 4) tax and customs incentives are provided in accordance with the legislation, in particular: communal land in the amount less than the land tax (by decision of local governments);

- exemption from income tax for residents of industrial parks for 10 years, provided that the profits are used to develop the activities of the participant of the industrial park within the industrial park;
- exemption from VAT of new equipment (equipment) for own use;
- establishment of real estate tax benefits by decision of local governments;
- setting the rate of land tax and rent for state and communal land in the amount less than the land tax (by decision of local governments);
- exemption from land tax (by decision of local governments);
- exemption from customs duties of new equipment imported by participants of industrial parks for their own use.














BENEFITS FOR - INVESTORS

Investment Regime" (Article 23) and the Customs Code of Ukraine (Article 287) stipulate that goods (except for goods for sale or use for purposes not directly related to business activities) are imported into the customs territory Ukraine for a period of at least three years by foreign investors for the purpose of investing on the basis of registered agreements (contracts) or as a contribution of a foreign investor to the authorized capital of an enterprise with foreign investment, are exempt from import duties.

The Law "On State Support of Investment Projects with Significant Investments in Ukraine" provides for the provision of state support to Ukrainian and foreign investors in order to attract investment funds for economic development

INVESTMENT PROJECT WITH SIGNIFICANT INVESTMENTS

must meet the following requirements:

- 1 be sold in the processing industry (except for activities for the production and circulation of tobacco products, ethyl alcohol, cognac and fruit, alcoholic beverages), extraction for further processing and / or enrichment of minerals (except coal and lignite, crude oil and natural gas), waste management, transport, warehousing, postal and courier activities, logistics, education, scientific and technical activities, health, arts, culture, sports, tourism and resort and recreational areas;
- 2 the project must provide for the construction, modernization, technical and / or technological re-equipment of investment objects in certain areas, purchase of necessary equipment (equipment) and components for it;
- 3 creation during the project implementation period of at least 80 new jobs with an average salary of employees, the amount of which is at least 15 percent higher than the average salary for the relevant activity in the region where the project is implemented for the previous calendar year;
- 4 the amount of investment in investment objects during the project implementation period must exceed the amount equivalent to 20 million euros;
- 5 the term of implementation of an investment project with significant investments does not exceed five years.

can be provided to the investor in the following forms:

- 1 exemption from January 1, 2021 to January 1, 2035 from VAT taxation of operations on import by an investor into the customs territory of Ukraine of equipment for the implementation of an investment project within the framework of a special investment agreement;
- 2 exemption from taxation of income tax of the investor's enterprise with significant investments after the commissioning of the object of investment project implementation for five consecutive years within the term of the special investment agreement;

- 3 exemption from import duty on equipment imported by the investor in the framework of the investment project. The list and volumes of such goods are approved at the governmental level simultaneously with the conclusion of a special investment agreement;
- 4 establishment by local governments of the land tax rate and rent for land of investors implementing a project with significant investments in a smaller amount or exemption from payment of this tax;
- local budgets and other sources not prohibited by law, the construction of related infrastructure (roads, communication lines, means of heat, gas, water and electricity, utilities, etc.), the necessary for the implementation of an investment project with significant investment.

The total amount of state support for an investment project with significant investments should not exceed 30 percent of the planned amount of investment under the project.

Support for the preparation and implementation of investment projects with significant investments is provided by the state institution "Office for Attracting and Supporting Investments"


